Mark Dockser: The RFP is due to be issued in a few weeks for feasibility study consultant

selection. Perhaps by September 2023.

4. Finance Working Group:

John Sasso to come up with a plan to review financial impact with Senior related programs.

Five key areas are being researched

5. Transportation: Explore transportation best practices for Seniors

John O'Neill – Does it expand beyond travel back-n-forth to Senior Center? What are the transportation options?
Other towns. Andover is has something worth looking into.

Review of Tom Mottl's transportation plan.

Volunteer Program like TASC – Transportation Assistance for Seniors Citizens. Contractor transportation or invest in technology to help manage pickups.

Mass Council on Aging - may have some good information transportation for seniors.

The intend is expand transportation beyond just transportation to-from Senior group. Mass General has subsidized Uber/Lyft transportation into Boston.
